II. Purpose of Addendum

Facility has completed construction of a single-story addition that will increase the total number of licensed beds to 62.

III. Methodology

The facility is currently licensed for 38 beds. The renewal license was issued on 10/23/13, and I inspected the facility's new addition on 02/19/14.

IV. Description of Findings and Conclusions

The new addition includes a secured memory care unit with nine rooms (12 beds), and six rooms (12 beds) for the general population. The exit doors will sound an alarm when the door bar is pressed and the lock releases in 15 seconds. When the door alert system or a resident call light is activated, a display panel lights up in the resident care office and on pagers carried by staff. This will identify the location of the exit door breached and the resident's room where assistance is requested. The exit doors cannot be opened from the outside except by using a coded keypad. The facility will provide a bed, mattress, and night stand; residents may bring their own furnishings space permitting.

On the general population side, the facility added a large community room, office space, and a public bathroom. There is a large gated courtyard between the memory care unit and the general population which is secured with a coded keypad. The new resident rooms have a handicap accessible private bathroom with a shower stall that has a fold down seat, a toilet, grab bars as required, and a sink. The living space has a small refrigerator with internal thermometers. Two resident rooms/units have three pull cords to call for assistance located in the bedroom area, the living room area, and in the bathroom. Four other rooms/units have four pull cords located in the bedroom area, two in the living room area, and one in the bathroom.

The memory care unit is designed to accommodate residents seeking specific services for dementia or related conditions, and it is secured with a keypad door lock. It has its own hair salon; kitchen, dining area; living room space; a secured laundry room; locked medication room; and a resident care station for staff to maintain records. Resident rooms also have pull cords to alert staff for assistance located in the bed room area and in the private bathroom that has a toilet and sink. Bathing and/or showers are done in either the spa room or in the shower bathroom. The Spa has a shower with a fold down seat, a therapeutic tub for bathing, a sink, a toilet, and there are grab bars as required. The shower bathroom has a shower stall with a fold down seat, a sink, a toilet, and it has grab bars as required. The spa room and the shower bathroom also have emergency call lights, and they have an overhead heat lamp on a timer to optimize resident comfort while being bathed. The windows are secured and can only be opened a few inches to prevent undetected elopement through a window. The windows are also secured to prevent them from being tilted open inwardly by residents and a special "key" has to be used to allow

staff to tilt the window open for cleaning purposes.


The facility has a certified recreation therapist (CRT) who will manage/oversee the facilities activities program for both the general population and for the memory care unit; facility staff will help to implement the activities. The CRT has developed several "Reminiscent Kits" designed to stimulate the five senses. Other activities include Picture Bingo, Artistic Creations, Music Group, Picture Lacing, Movie & Popcorn night, Conversation Hour, Parachute, Balloon exercises, Water coloring, and games such as Sort It Out, Stretch It Out, Blow-up Bowling, Name that Tune, Who's That?, Ring Toss, horseshoes, and Word Beginnings; outside entrainment is also scheduled at least weekly and more on some weeks. Activities will be scheduled throughout the day including weekends.

All employees will be trained and having continuing education on Alzheimer's and related conditions, resident service plans, scheduled activities, how to assist residents with activities of daily living, and how the meet the special needs of individuals who have dementia and related conditions. Training includes techniques on redirecting residents into appropriate activities, behavior interventions for elopement precautions, and how to care for a resident who is resisting care.

I reviewed the required documents required for compliance with MCL 333.20178 and the facility is in compliance. The Bureau of Health Care Services' Health Facilities Engineering Section has approved occupancy for a total of 62 beds.

V. Recommendation

I recommend increasing the facility's total license bed capacity to 62.
