II. Purpose of Addendum

Licensees, Jack and Kareen Boehmer, have requested an increase in capacity based on the approval of a new bedroom for resident use.

III. Methodology

04/25/2014 – Document Received – Request for Modification of Terms of the License

04/28/2014 – On-Site Inspection - conducted as part of the license renewal inspection

IV. Description of Findings and Conclusions

The licensees' requested that the bedroom currently used by their daughter in the bedroom area of the home be approved for resident use. They plan to allow their daughter to use the bedroom until they need it for a resident. The bedroom is fully furnished and they also have extra furniture for when the daughter moves her bedroom into the sunroom on the lower level of the home.

The bedroom measure's 11'11" x 9'5" for a total of 112 square feet of usable floor space. All the measurements are on file. The bedroom is designated as C on the file floor plan. The room has 2 windows and a built in closet.

The home's living room and dining room combine for a total of 442 square feet which allows for the increase in resident capacity of the home.

V. Recommendation

It is recommended that the capacity of Chickadee Ridge A.F.C. be increased from 4 to 5 effective this date. The licensees have agreed to notify the licensing consultant when they begin to use the bedroom for resident use.
