III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Physical Description of Facility

The Willows of Okemos is a newly constructed single-story building located at 4830 Central Park Drive, Okemos, MI 48864. They are seeking licensure for a maximum bed capacity of 24 resident beds. The home for the aged is connected to a newly constructed 68 bed nursing home. The home for the aged is separate and distinct from the nursing home utilizing separate living spaces and separate entry doors. The facility is barrier-free. The home for the aged consists of 16 single bed apartments and four apartments which will accommodate two individuals each.

Just inside the front door is a lovely living room and dining room. Just to the left of the living room is an activities room, computer room and work-out room. Down the hall to the left are home for the aged apartments, a lounge, nursing station, and café.

Pull-cords to summon staff assistance are located in each resident apartment next to each bed, in the bathroom next to the toilet and inside the shower. When a cord is pulled a light outside the resident apartment is illuminated and an alarm sounds at the nursing station. Cameras are located on each hallway and the view is transmitted to a monitor in the nursing station to allow remote observation of the resident hallways.

The facility provides each resident with a bed and dresser. Individuals may opt to bring their own furniture. Each apartment has its own heat and air conditioning controls. The building is fully sprinkled and is equipped with a generator. Smoking is not permitted anywhere inside the facility or on the premises. The facility is connected to city water and sewage disposal. The Willows of Okemos is located near several shopping areas, restaurants, and lovely parks.

B. Program Description

The licensee for The Willows at Okemos is Trilogy Health Care of Clinton, LLC located at 303 N. Hurstbourne Pkwy Louisville, KY 40222-5185. The designated Authorized Representative and Administrator is Ryan Michelson. Mr. Michelson has several years' experience working with the elderly and as a home for the aged administrator.

The Willows of Okemos will provide services to men and women who are 60 years of age and older. They will provide twenty-four hour supervision, room, board and assistance with personal care, including medication administration. The home will offer three meals daily and hydration and snacks are provided and available throughout the day.

The home will offer scheduled activities and life enrichment events daily. The home has available transportation and an optional resident trust fund account is available.

The policies and procedures of The Willows of Okemos including resident contracts, admission and discharge policies, and disaster planning and day to day administration were reviewed.

The administrator was provided technical assistance on the statutory requirements (Section 333.20173(1a) of PA 368) pertaining to the hiring or contacting of persons who provide direct services to residents.

C. Rule/Statutory Violations

The study has determined substantial compliance with applicable licensing statutes and administrative rules.

IV. RECOMMENDATION

Based upon the findings, I recommend issuance of a temporary license to this home for the aged. The terms of the license will enable the licensee to operate an HFA for 24 residents and will be for a six month period effective 6/09/2014.
