IV. Description of Findings and Conclusions

In a 7/2/14 email message, the facility's authorized representative, Dean Solden, called the home SternsLodge. The facility's building program plan for installation of an emergency generator called the facility SternsLodge. Mr. Solden stated that this is what the facility was called internally but the sign in front of the building named the facility Vibrant Life Senior Living Temperance. Mr. Solden submitted an updated HFA License Application changing the facility's name to Vibrant Life Senior Living Sterns Lodge.

V. Recommendation

Modify the facility's licensed name from Vibrant Life Senior Living OC Temperance to Vibrant Life Senior Living Sterns Lodge.
