## **IV. Description of Findings and Conclusions**

The licensee organization notified administrative staff of the Bureau of Children and Adult Licensing of the pending change in controlling interest of the licensee organization, Lifehouse Prestige Commons Operations LLC. The change was made effective 8/29/2014.

On 9/5/2014, I received and reviewed copies of the new lease and management agreement, listing of the board of directors, current organizational chart, letter of designation by the board of directors of the individual authorized to act on behalf of the corporation (the same licensee designee and administrator of record), and current financial statement. Per the letter from the attorney handling this change, the Program Statement, Admission Policy, Discharge Policy, Job Descriptions, and Personnel Policies in effect for the facility and on file with the Bureau remain unchanged.

On 9/8/2014, I received the Adult Foster Care Corporate Application (BCAL 569-C). The licensee designee, Teresa Fowler confirmed by telephone on 9/9/2014 that the mailing address for the corporation remains unchanged.

I have reviewed and approved all documents as submitted. The licensee remains in good standing.
