A magnetic hold open device has been installed on the room door to ensure that the room door for Room 21, Room 22, Room 23, and Room 24 will stay open if needed by the resident and deactivate to close the door in the event of a fire.

V. Recommendation

Therefore, it is recommended that the licensed bed capacity of StoryPoint of Midland, a home for the aged be increased from 38 beds to 42 beds, effective 9/08/2014.
