II. Purpose of Addendum

Modification of terms of the license to expand the age range for admission to ages 45 through 99 years and to add the designation of the facility as wheelchair accessible.

III. Methodology

10/16/2014 Receipt of Request to Modify the Terms of the License/Registration.

10/22/2014 Receipt of revised program statement and description of the facility.

10/22/2014 On-site inspection; full compliance. Wheelchair ramp at the front (main egress) inspected for compliance with R400.14509. Wheelchair ramp at the side entrance of the home had been assessed for compliance at the time of original license issuance.


IV. Description of Findings and Conclusions

The licensee designee, Ferdinand Policarpio, submitted a request to modify the terms of the license to expand the age range for adults admissible to the facility. The age range had been previously designated as ages 50 – 99; the request is to amend it to ages 45 – 99. Mr. Policarpio submitted a revised program statement with his request which I reviewed and approved on 10/22/2014.

Mr. Policarpio also informed me that a second wheelchair ramp had been installed. Per R400.14509, two ramps are required for small group homes. I inspected the new ramp during an on-site inspection 10/22/2014 and confirmed that it complied with the specifications detailed by rule. I had inspected the ramp at the side entrance of the home when I issued the original license, having determined that it also complied with licensing rules. At that time, I had also assessed the interior structure to confirm that it was barrier free and the widths of bedroom and bathroom doorways were at least 30 inches wide.

V. Recommendation

I recommend modification of the terms of the license to expand the age range of residents to ages 45 – 99 and designation of the facility as wheelchair accessible.
