Gardenview has requested an increase in capacity.

III. Methodology

07/24/2014 Telephone call received request for capacity increase.
08/05/2014 On-site inspection measured rooms
08/12/2014 Reviewed previous HFES report.
09/29/2014 Sent 1605 to management company to submit for plan review.
10/07/2014 Received approval from HFES to increase capacity from 47 to 51.
10/15/2014 Telephone call made to BFS John Elenbaas

IV. Description of Findings and Conclusions

The facility has ample day/dining floor space based on the HFES report but they are lacking window space in the facility. The facility contacted HFES to determine what they would need to do to increase the capacity.

The facility has converted a conference room into a recreation area for resident use. Based on the report received from HFES this allowed an increase from 47 residents to 51 residents.

I called the Bureau of Fire Services to be sure that this increase would not require an approval from them. Mr. Elenbaas stated that as long as they are not making any modifications to the building that they do not require an inspection.

V. Recommendation

I recommend a capacity increase to 51 residents.
