**II. Purpose of Addendum**

Increase the capacity from 4 residents to 5.

**III. Methodology**

On 11/29/2014 Licensee Tuana Lothery of C.M.L. Homes sent in a Request for Modification of the Terms of the License/Registration requesting an increase in the capacity of C.M.L. Homes from 4 residents to 5.

**IV. Description of Findings and Conclusions**

On 12/03/2014 I measured the lower level bedroom to assess whether or not there was enough room for one resident. Using the rule R400.1432 (2) Bedroom space; "usable floor space" defined, I determined that this lower level bedroom did have enough space to accommodate one resident. The living area of the facility has enough space to accommodate an increase of one resident also.

**V. Recommendation**

The Department supports Licensee, Tuana Lothery's request to increase the capacity of C.M.L. Adult Foster Care Family Home from 4 residents to 5.
