
A corporation division business entity search of the Michigan Department of Licensing and Regulatory Affairs Corporations, Securities & Commercial Licensing Bureau website revealed SZR North Ann Arbor Senior Living, LLC terminated the assumed name Atria Ann Arbor; and registered the assumed name Atria Park of Ann Arbor on 10/16/2014.

IV. Description of Findings and Conclusions

Licensee SZR North Ann Arbor Senior Living LLC will operate and contract with residents under the assumed name Atria Park of Ann Arbor.

V. Recommendation

It is recommended that the name of the licensee be changed from SZR North Ann Arbor Senior Living, LLC to their assumed name Atria Park of Ann Arbor. Also, the name of the facility will change from Atria Ann Arbor to Atria Park of Ann Arbor.
