## II. Purpose of Addendum

Licensee added an addition to the existing adult foster care small group home and created enough space to add an office, bathroom, and two additional resident bedrooms.

## III. Methodology

04/25/2014 – Telephone call received. Request for Modification of the Terms of the License Received.

05/09/2014 – On-site Inspection Completed – full compliance.

05/13/2014 – Written request for modification of license.

## IV. Description of Findings and Conclusions

Cornerstone II, Inc. was originally licensed on 12/21/2009 for a capacity of four residents. The facility is a single story structure with all bedrooms and other living areas located on the main floor. The licensee added an addition to the existing facility that includes; two resident bedrooms, an office, and a resident bathroom.

Bedroom 3 South and Bedroom 4 North, contain in excess of the required 80 square feet of usable floor space per bed. Bedroom 3 East and Bedroom 4 West have bedroom furnishings that meet the licensing requirements. The living room of the home contains 224 square feet of living space which is adequate for 6 residents living in the home. The kitchen and dining room are adequate for the increased capacity.

## V. Recommendation

It is recommended that the licensed capacity of Cornerstone II, Inc. be increased from 4 to 6 residents effective 05/16/2014 based on the remodeling completed in the home.
