## **II. Purpose of Addendum**

To increase the capacity from 3 to 4 adult foster care residents.

## **III. Methodology**

On 06/25/2015, I made an onsite inspection and measured the third bedroom, and obtained the written request to increase capacity from 3 to 4 adult foster care residents from Rita Lopez.

## **IV. Description of Findings and Conclusions**

The third bedroom is 8'8" by 11'4" for a total of 98 square feet. As stated in the Original License Study Report, the total living space in this home is 328 square feet, which still meets the requirement of 35 square feet of living space for four residents.

## **V. Recommendation**

I recommend that the capacity of this home be increased from 3 to 4 adult foster care residents.
