#### II. Purpose of Addendum

The licensee has requested a licensed capacity increase from 47 beds to 61 beds.

## III. Methodology

I reviewed the revised application from John Czarnecki, Jr., the authorized representative for the licensee, Memorial Assisted Living, LLC., and the revised Room Sheets from Andrea Humphrey with Health Facilities Engineering Section, in the Department of Licensing and Regulatory Affairs.

# IV. Description of Findings and Conclusions

The original license, for 47 beds, was issued on 5/13/2015. A revised application was received with a capacity change to a total of 61 beds. Revised Room Sheets were received, 5/14/15, from Andrea Humphrey, Health Facilities Engineering Section, increasing the number of beds from 47 to 61.

These Room Sheets indicate that, in the general area, there will be double occupancy in twelve suites; six suites measuring 188 square feet, three suites measuring 212 square feet, and three suites measuring 317 square feet.

In the memory care program, there will be double occupancy in two suites; one suite measuring 317 square feet, and one measuring 188 square feet.

### V. Recommendation

I recommend that the bed capacity be increased 14 beds, from 47 beds to a total of 61 beds.
