II. Purpose of Addendum

The licensee(s) requested to use the main floor of the facility for residents.

III. Methodology

On 08/18/2015, I conducted an on-site inspection.

IV. Description of Findings and Conclusions

The main floor consists of a living room, kitchen & dining room area, formal dining room, 2 full bathrooms, 3 resident bedrooms, and a live-in staff bedroom with a bathroom. Resident bedrooms measure: 1.) $14' \times 14' = 196$ sq. ft. for 2 residents, 2.) $11' \times 14' = 154$ sq. ft. for 2 residents, 3.) $14' \times 18' = 252$ sq. ft. for 2 residents. The living, dining & formal dining room areas measure a total of 1,080 sq. ft which exceeds the 35 sq. ft. per person requirement.

V. Recommendation

I recommend that the main floor of the facility be used for residents.
