On 4/29/2015, Justina Ude-Agha submitted a request to change the terms of her license to add wheelchair accessible to her license.

An on-site inspection was conducted on 5/11/2015 and again on 7/1/2015.

## IV. Description of Findings and Conclusions

Ms. Ude-Agha added wheel chair ramps to the front and back entrances of the home. During the my second inspection on 7/1/2015 I determined that the ramps are in compliance with licensing requirements. Ms. Ude- Agha also provided a copy of the final inspection report from the city of Inkster building department dated 6/24/2015, indicating that the ramps had been approved.

#### V. Recommendation

I recommend that the terms of the license be changed to add wheelchair accessible.
