II. Purpose of Addendum

The purpose of this Addendum to the Original Licensing Study is to change the use of bedroom space and to approve the addition of a bathroom and upstairs laundry room.

III. Methodology

On July 15, 2015, a Request For Modification Of The Terms of The License was completed and submitted.

On September 23, 2015, I inspected the addition of 2 private bedrooms, the addition of another bathroom, and the addition of an upstairs laundry room all of which was converted from the garage on the north end of the facility. I inspected the other 2 private bedrooms that were converted from semiprivate bedrooms, and the 1 existing semiprivate bedroom.

On September 23, 2015, I measured the 2 private bedrooms that were added to the facility, reviewed the floor plan, and emergency evacuation plan.

On September 23, 2015, I completed environmental health and fire safety inspections.

IV. Description of Findings and Conclusions


The Request For Modification Of The Terms Of The License was reviewed. It proposed changing bedrooms 1 and 2 from semiprivate bedrooms to private bedrooms, leaving bedroom 3 as a semiprivate bedroom, and adding private bedrooms 4 and 5. It also proposed adding another bathroom and an upstairs laundry room.

Private bedrooms 1 and 2 each contained 1 bed and semiprivate bedroom 3 contained 2 beds. Private bedroom 4 contained 121.63 square feet of space and private bedroom 5 contained 133.84 square feet of space. These bedrooms were adequately furnished and contained closets and windows. They were protected by the facility's hard-wired smoke detection system.

The bathroom and laundry room were in compliance with the environmental health and fire safety rules at the time of inspection. Emergency evacuation routes were posted.

V. Recommendation

I recommend change in the use of bedroom space and the addition of another bathroom and laundry room as indicated in the Description of Findings and Conclusions section of this report. There are currently 4 private bedrooms and 1 semiprivate bedroom, 3 bathrooms, an upstairs laundry room and a laundering area in the basement.
