### II. Purpose of Addendum

To approve use of additional bedroom and re-evaluate licensed capacity.

## III. Methodology

I completed an onsite inspection on 04/06/2016 to view and measure Bedroom #4.

#### IV. Description of Findings and Conclusions

On 04/06/2016 the licensee explained that she converted the garage into a double occupancy bedroom and wanted approval to use it. The request was followed-up in writing.

The home was originally licensed for 5 residents with the following dimensions:

Bedroom #1-175 sq ft (2 residents)

Bedroom #2-114 sq ft (1 resident)

Bedroom #3-131 sq ft (2 residents)

On 04/06/2016 I viewed and measured Bedroom #4. It had all the required furnishings and a full bathroom. The dimensions and capacity was as follows:

Bedroom #4 17 X 17=289 sq ft (2 residents)

Bedroom #3 was converted to a single occupancy room.

Based on the bedroom dimensions and the licensee's request to increase capacity, I conclude the home can accommodate 6 residents.

#### V. Recommendation

I recommend increasing capacity from 5 to 6 residents.
