**II. Purpose of Addendum**

To reduce capacity to four residents and increase first floor bedroom capacity to two.

**III. Methodology**

**IV. Description of Findings and Conclusions**

On 6/17/16, the licensee submitted measurements from a licensed contractor to evidence her first floor residents’ bedroom had 132 sq.ft. The licensee also requested that her capacity size be reduced from six to four residents. Therefore, the facility’s first floor resident’s bedroom is now licensed for two residents and the facility’s capacity is reduced to four.

**V. Recommendation**

I recommend that the status of the license remain unchanged.


