III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Physical Description of Facility

Resthaven Maple Woods Cottage is a single-story building comprising of east and west corridors that are connected in the middle by the main entrance, reception area, dining area, commercial kitchen, bistro area, and administrative offices. The bistro area consists of an oven, microwave, refrigerator, and beverage bar that is available for resident and guest use. Both corridors have a main sitting area equipped with an electric fireplace. There are enclosed family/multipurpose rooms on each corridor for residents and visitors to utilize. The west corridor contains a salon and separate spa room. There is a fenced courtyard off the main dining room.

The facility contains 24 single occupancy resident rooms. The east and west resident corridors have identical layouts. Each room is equipped with a closet and locked storage unit located directly outside of the rooms. All rooms are outfitted with a full size bathroom containing a sink, toilet, and walk in shower. Each room has

individual temperature controls and keyed doors. Each room and bathroom have a call button system, that when activated alerts the care staff on their smart phones. Both corridors have south facing fenced courtyards that offers exterior sitting areas. These exit doors will be unlocked during the day and locked at night with alarm system activated. All exterior doors of the facility have magnetic locking mechanisms that will release within fifteen seconds of constant applied pressure of activation of the fire suppression system. Similarly, the breaching of these locks notifies staff that an exit occurred. The entire facility is air conditioned.

The facility is outfitted with an approved fire suppression system throughout the building. On 5/9/17, the Bureau of Fire Services granted an acceptable fire safety certification.

On 5/9/17, the Health Facilities and Engineering Section granted Maple Woods Cottage occupancy approval of its building.

The facility building and grounds are a smoke free environment.

The facility is located one mile from Holland Hospital and eight miles from Zeeland Community Hospital. Local pharmacies, banking, retail and food establishments are within minutes from the facility.

Resthaven Non-profit Corporation owns the land the facility is on. A review of the Department of Licensing and Regulatory Affairs' business entity and search revealed valid registration for Resthaven.

B. Program Description

Maple Woods Cottage provides services to men and women who are 60 years of age and older. The facility provides room, board, twenty-four hour supervision and assistance with personal care including medication administration. The facility allows residents to choose their own primary health physician, specialist, licensed health agency and/or hospice. The facility allows residents to choose their own personal pharmacy, Veteran Affairs if eligible, and/or the facility's contracted pharmacy.

C. Rule/Statutory Violations

The facility is in substantial compliance with the home for the aged public health code and administrative rules.

IV. RECOMMENDATION

I recommend issuance of a temporary license to this home for the aged that will allow it to operate a for a six-month period of time with a licensed bed capacity of 24.
