II. Purpose of Addendum

On 2/7/17 I received a request to modify the terms of the original LSR to include a bedroom for residents on the upper level of the home which had previously been used for staff.

III. Methodology

On 2/7/17 I received a Request for Modification of the Terms of the Registration/License from Licensee Julie Brooks.

On 3/9/17 I conducted an inspection of the upstairs bedroom. The dimensions of the new room is 11 x 15.25 to equal 167.75 for up to 2 residents. This home may now accommodate up to 12 residents.

IV. Description of Findings and Conclusions

The modification of the terms of the registration/license is added to the Original Licensing Study to show the availability of the bedroom on the upper level of the home to be adequate for Resident use. After an inspection of the bedroom, a determination has been made that the space is appropriate for resident use.

V. Recommendation

I recommend the additional space of this bedroom to be added to the Original Licensing Study. After an inspection of the space a determination has been made that the space is appropriate for resident use.
