IV. Description of Findings and Conclusions

On 08/07/17, I received a request to modify the terms of the license. Kenneth Jordan, license designee requested that the capacity be reduced from 5 to 4 in order to convert a bedroom to an office for the home manager, who is no longer able to ambulate up and down stairs.

On 08/10/17, I conducted an onsite inspection and observed that the west resident bedroom, located closest to the bathroom has been converted to an office. The bedroom at the time of conversion was empty as the home currently has 3 residents.

V. Recommendation

I recommend that the capacity be reduced, as requested by Mr. Jordan. The total resident capacity will be reduced from 5 to 4.
