II. Purpose of Addendum

Licensee requested an increase in capacity after furnishing another bedroom for resident use.

III. Methodology

08/24/2007 – On-site inspection completed
08/27/2007 – Corrective Action Plan received and approved

IV. Description of Findings and Conclusions

Licensee has converted master bedroom of the home into a 3-person bedroom, and the licensee and her husband will use a smaller bedroom for their sleeping area.

The bedroom contains over 211 square feet, which provided for 65 square feet per resident. Enclosed within the bedroom is a fully equipped bathroom, including a walk in shower for the occupants of the bedroom. The home has adequate living space to accommodate the increase in capacity request.

The home now contains 2 bedrooms, 3 residents per bedroom, as the licensed bedrooms approved for this home.

V. Recommendation

It is recommended that the licensed capacity from this adult foster care family home be increased for 4 to 6 residents effective 08/27/2007.
