II. Purpose of Addendum

To include the addition of two bedrooms to the home. The home now has 6 private bedrooms.

III. Methodology

08/10/2017	Inspection completed on-site.
08/29/2017	Contact-Document received Written request for modification of terms of the license.
09/13/2017	Modify Terms Change in use of space included the addition of two bedrooms to the home.

IV. Description of Findings and Conclusions

I conducted an on-site inspection on 08/10/17 and measured the two additional bedrooms that were added to the home. I also measured the original four bedrooms to ensure that no space was taken from them. The addition of the two bedrooms did not take away from the minimum of 35 square feet per resident requirement.

Resident bedrooms were measured during the on-site inspection and have the following dimensions:

Based on the above information, it is concluded that this facility can accommodate **six** (6) residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

V. Recommendation

I recommend the homes licensed capacity remains at six (6). The home has changed the use of space which included the addition of two additional bedrooms. The home now has six (6) private resident bedrooms.
