II. Purpose of Addendum

The purpose of the addendum is to add mentally ill to the program type and special certification of Adams Home.

III. Methodology

10/10/17 - I received program statement, admission/discharge policy, and application for certification from administrator, Julia Jeffreys, requesting a modification to add mental illness to the special certification.

10/13/17 - I reviewed current license file, licensee information in BITS, training documentation, experience and education of the licensee designee and administrator, training of direct care staff, revised program statement, and admission/discharge policy.

IV. Description of Findings and Conclusions

Based on the information received and documents reviewed, the licensee designee, Gloria Mitzelfeld, and the administrator, Julia Jeffreys, meet the requirements to provide services to mentally ill adults. Gloria Mitzelfeld, the licensee designee, has a bachelor's degree in psychology and has worked with individuals who have developmental disabilities and/or mental illness since 1978. She has also worked with Dr. John McGee promoting Gentle Teaching for both populations for many years.

Julia Jeffreys, the administrator, has a bachelor's degree in psychology and is a registered social worker with the state of Michigan. She has worked in the mental health field since 1994. As a registered social worker, she is required to obtain 45 hours of continuing education over a three year period. All employees at Adams Home receive training through the Macomb Oakland Regional Center (MORC), which includes modules on mental illness and developmental disabilities. LADD Inc. also provides a separate training for employees about mental illness.

Gloria Mitzelfeld currently operates several adult foster care facilities for individuals with mental illness. Both Gloria Mitzelfeld and Julia Jeffreys possess the training and qualifications required to provide services to mentally ill adults.

V. Recommendation

I recommend that mentally ill be added to the program type and special certification of Adams Home.


