II. Purpose of Addendum

The licensee modified the original floor plan of the facility by turning double bedrooms into single bedrooms to allow more privacy for residents. This modification required the construction of additional space to the facility.

III. Methodology

09/29/2017 - Document Received - Plan Review from Bureau of Fire Services

10/12/2017 – Document Received - Email from Melissa Williams, Licensee Designee, that the renovations were almost completed

10/17/2017 - Document Sent - Emailed Ms. Williams to let her know a Request for Modification of the Terms of the License was needed

10/25/2017 – Document Received – Request for Modification of the Terms of the License Received

11/03/2017 – Inspection Completed On-Site – full compliance

IV. Description of Findings and Conclusions

Anchor Pointe North was originally licensed on 08/03/2005 for a capacity of 10 residents in a total of five bedrooms. The licensee constructed additional space on the West side of the facility, which is accessible by the original building or from the building's own door on the North end. The additional space consists of five bedrooms and a common area for the residents. The new common area is 30.3' x 15.3' totaling 463.59' total square footage. There is also a small mechanical room that contains a new furnace, which was serviced on 07/28/2017, but this room is kept locked and is not accessible to residents. The construction allows each resident to have his own bedroom with more privacy.

The space in the original five bedrooms (1-5) is unchanged; however, there is now only one bed per room.

The five new bedrooms (6-10) contain in excess of the required 80 square feet of usable floor space per bed. The bedroom furnishings meet the licensing requirements. The resident bedrooms were measured during the on-site inspection and have the following dimensions:

V. Recommendation


