**II. Purpose of Addendum**

The licensee made a written request to increase the capacity of the facility from ten to twelve residents. The additional two residents will be adults referred from the community.

**III. Methodology**

The facility was inspected on August 8, 2003 to assess available space to increase the capacity. There are currently two unused bedrooms in the facility and an additional full bathroom. The larger of the two bedrooms could house one or both of the additional residents while the 2<sup>nd</sup> bedroom could house one additional resident.

**IV. Description of Findings and Conclusions**

The facility was found to be in compliance with Adult Foster Care Licensing Rules.

**V. Recommendation**

I recommend that the facility increase capacity to twelve residents.
