### II. Purpose of Addendum

On 01/24/2018, Licensee, Tuana Lothery submitted a Request for Modification of the Terms of the Registration/License form with a request to change the capacity of the AFC Family Home license from 5 resident capacity to 6 resident capacity.

### III. Methodology

On 01/25/2018, an inspection of the facility and room was conducted, measurements of the bedroom taken. The resident bedroom located in the lower level of the facility on the East side of the home, has the following measurements:

12.25X10.17=124.58 square feet of space divided by 65 required for each resident = 1.91. Room for 1 resident. (Measurements 12ft. 3inches by 10feet 2inches)

### IV. Description of Findings and Conclusions

According to R 400.1432, Bedroom space; "usable floor space" defined.

(2) A bedroom shall nave not less than 65 square feet of usable floor space per bed. This AFC Family Home bedroom can accommodate one (1) resident. The living area of the facility has enough space to accommodate an increase of one resident.

#### V. Recommendation

I recommend the increase of capacity from 5 residents to 6 residents for this AFC Family Home License.
