II. Purpose of Addendum

The facility requested an increase in capacity from 2 to 3.

III. Methodology

On August 26, 2018, Mrs. Delmet sent an email requesting information on what it would take to increase her capacity from 2 residents to 3. She stated that she would be moving the residents upstairs and she would be taking the bedroom downstairs.

On August 28, 2018, I shared the requirements for adding an additional resident to her license and the square footage that is required. I let Mrs. Delmet know that when she is ready to contact me and I can do an inspection.

On October 8, 2018, Mrs. Delmet let me know that her husband is retiring in November or December and that she has taken steps to add him as an employee and that they are almost ready for my inspection.

On November 7, 2018, I received an email stating that the bedrooms have been switched from the main floor to upstairs. I let her know I could come on 11/9/2018.

On November 9, 2018, I made an onsite visit to measure the bedroom. The upstairs bathroom has a full bathroom off of it and a common area for the residents to sit and watch tv.

IV. Description of Findings and Conclusions

The residents new bedroom is located on the second floor. It is 12'.4" x 16' or 198 square feet. There is 3 feet between the beds and the square footage meets the requirements. There is a full bathroom just off the bedroom and there is a common area that also measures 198 square feet.

The 2 residents in the home were there and are very happy with the new room and the common area they have.

V. Recommendation

I recommend increasing the capacity from 2 to 3.
