II. Purpose of Addendum

On September 25, 2018, Eric and Karen Jefferies, Licensees submitted a *Request for modification of the Terms of the Registration/License* requesting a change in use of space. The Jefferies have added a bedroom with an en suite-bathroom to allow private bedrooms for the two residents for whom they are licensed.

III. Methodology

The request for change in space and new floor plans were received on September 25, 2018. An on-site inspection was completed on October 05, 2018.

IV. Description of Findings and Conclusions

On October 05, 2018 an on-site inspection was completed. The new bedroom measured 8'8" x 9'5", yielding 83.6 sq. ft which is sufficient space for one resident. The bedroom also includes a full private bathroom. Mr. Jefferies has submitted a revised floor plan, noting the bedroom and bathroom being added using space of the sitting room. Sitting room dimensions are now 12' x 12', yielding 144 sq. ft, leaving 704 sq. ft of living space which meets/exceeds the 35 square feet per occupant required.

V. Recommendation

I recommend approval for the change of space, by adding a private bedroom and bathroom by converting space from the sitting room so that each resident has their own private bedroom and bathroom. NOTE: The licensed capacity of this home remains at two residents.
