II. Purpose of Addendum

The purpose of this addendum is to define and outline the development of a memory care program with the intent to operate solely as a memory care facility.

III. Methodology

On 5/16/18, facility staff submitted documentation and description of services in accordance MCL 333.20178. On 8/8/18, an onsite inspection was completed.

IV. Description of Findings and Conclusions

Vicinia Gardens Transition is a memory care facility that provides room, board and supervised personal care services to men and women ages 55 and older with cognitive and/or memory impairments. Resident's needs are assessed and outlined within their service plan to provide for the specific needs of each resident. All care staff receive specialized dementia training during the onboarding process and offer additional trainings and in services to provide continuing education.

Vicinia Gardens Transition employs a full time Life Enrichment Director as well as support staff that provide a calendar of activities throughout each day including but not limited to Bible study, sing along, walking club, balloon volley ball, and various arts and crafts.

Vicinia Gardens Transition is a secured facility outfitted with exterior door locks which require a passcode upon entry and exiting. Exiting is controlled by 30 second delayed egress mag locks that contain key pad codes, STI Stop alarms, and contact alarms. All of the windows have stoppers on them and video surveillance is utilized in common areas. The facility also has a secure and enclosed courtyard. All residents wear electronic call pendants to alert staff when assistance is needed, in addition to having pull cords in their apartments. Door alarms, emergency call pendants and push cords alert staff through a pager system that care staff carry with them at all times. Additional notification is also sent to the staff care station if any alarms are triggered.

V. Recommendation

I recommend that Vicinia Gardens Transition operate as a memory care facility and the status of the license remain unchanged.
