II. Purpose of Addendum

On August 15, 2018 I was notified by Mr. Satish Ramade that he is the new owner of Margaret's Meadows LLC. Mr. Ramade is the 100% sole owner of Margaret's Meadows LLC and provided a copy of the Corporations Online Filing System and the Certificate of Change of Registered Agent with the Department of Licensing and Regulatory Affairs, verifying the change in ownership from David Martin to Satish Ramade. Mr. Ramade provided a new application without fee and a letter appointing Julie Williams as the Licensee Designee and Administrator .

III. Methodology

1. Reviewed the *Adult Foster Care License Limited Liability Company, Governmental Organization and Corporate Application*.
2. Reviewed documents appointing Julie Williams as the Licensee Designee and Administrator.
3. Reviewed Michigan Department of Licensing and Regulator Affairs Corporations, Securities, & Commercial Licensing Bureau and Corporations online filing System.
4. Review of LARA AFC application without a fee and letter appointing Julie Williams as the licensee designee and administrator.

IV. Description of Findings and Conclusions

It has been found that on July 13, 2018, Mr. David Martin sold 100% ownership of Margaret's Meadows LLC to Mr. Satish Ramade. The LARA Corporation Online Filing System shows Mr. Ramade and Margaret Meadows LLC is in good standings as a Domestic Limited Liability Company with Satish Ramade as the sole owner. On August 28, 2018 the department received an *Adult Foster Care License Limited Liability Company, Governmental Organization and Corporate Application* without fee for Margaret's Meadows.

Julie Williams has been appointed by Mr. Ramade as the Licensee Designee and Administrator. Documentation of the required competencies, education and resume reflecting the experience of Julie Williams was received and reviewed. Ms. Williams meets the one-year requirements of working with the physically handicapped, Alzheimer's, and aged populations as Ms. Williams was the home manager of Margert's Meadows under the direction of David Martin. On August 27, 2018, an *AFC/HFA Licensing Record Clearance Request* was completed on Ms. Williams. Ms. Williams has had finger printing completed due being an employee of the facility along with current TB Test, CPR/First Aid, and Medical Clearance.

V. Recommendation

It is recommended that the Original LSR be amended to show that Satish Ramade is the new sole owner of Margaret's Meadows LLC and that Mr. Ramade has appointed Julie Williams as the Licensee Designee and Administrator for Margert's Meadows.
