To increase the facility capacity from four to five.

III. Methodology

A request to increase the capacity was submitted by the licensee designee Adrienne Flowers. The facility is located at 18403 Kentucky Detroit, MI 48221. A main floor bedroom was added.

IV. Description of Findings and Conclusions

On 10/23/2018, I completed an onsite inspection for #AS820341954 Alternative Adult Residence Inc. The main floor bedroom measured 12'x6" by 6'x8" equals to 83 square feet. The room is furnished with bed, dresser, wardrobe cabinet, mirror, and chair. The bedroom has an attached bathroom with lavatory, sink, and shower. The shower is equipped with handrails and non-skid surface. Ms. Flowers understands that the resident housed in the main floor bedroom will have her privacy and no other residents, staff, and or persons will go thru the bedroom to use the attached bathroom.

V. Recommendation

I recommend that the capacity should be increased from (4) to (5) for facility #AS820341954 Alternative Adult Residence Inc.
