II. Purpose of Addendum

To modify the floor plan and original layout of the facility. Additionally, the licensee has requested the program type now include Alzheimer's patients.

III. Methodology

An onsite inspection was completed on 11/1/18 to inspect a 6th bedroom that was added since the issuance of the original license. Specifically, the garage was converted into a room addition. Bedroom #4 was converted to a single room. Bedroom #6 was added. Therefore, the home currently has 6 private rooms. Bedroom #6 is adjacent to the utility closet that houses the hot water tank. I also reviewed an updated resume submitted by Michael Farrell on 2/5/19. The licensee has obtained over 1,575 hours working with Alzheimer's patients since March 2017.

IV. Description of Findings and Conclusions

On 11/1/18, Bedroom #6 was measured with the following dimensions:

12.08 X 9.08 = 110 square feet

Mr. Farrell meets the qualifications to provide care to those identified in the home's revised program statement and admission policy.

V. Recommendation

I recommend the Original Licensing Study report is modified to accommodate 6 private rooms. It is also recommended the program type include the Alzheimer's population.
