On November 28, 2018, I conducted a renewal inspection at the facility. Also, the licensee submitted a request to modify the terms of the license; to increase the capacity from 2 to 4 residents. On 11/28/18, I measured the two other bedrooms for resident use.

# IV. Description of Findings and Conclusions

The licensee has an office on the main floor that she wants to make a resident bedroom. This bedroom, Bedroom 2 is 10' x 10'. The bedroom is 100 square feet. Therefore, can have 1 resident bed. On the second floor, the license has a non-resident bedroom that she wants to make a resident bedroom. Bedroom 3 is 10' x 10'. The bedroom is 100 square feet. Therefore, can have 1 resident bed.

## V. Recommendation

I recommend the capacity of this adult family home be increased from 2 residents to a capacity of 4 residents.
