#### II. Purpose of Addendum

The purpose of this addendum is to document an increase in licensed bed capacity. The facility added an east wing comprised of 20 double occupancy resident rooms. The facility requested to increase their capacity to 108 to include this addition.

### III. Methodology

On 10/23/18, I completed an onsite inspection at the facility, specifically observing the facility's newly added east wing. The new wing is comprised of 20 double occupancy resident rooms.

On 10/12/18, Health Facilities and Engineering completed their opening survey report. The report stated the addition was approved for resident occupancy. Bureau of Fire Services granted full fire safety approval on 9/20/18.

## IV. Description of Findings and Conclusions

Boulder Creek Assisted Living is a single story building. The newly constructed east wing is comprised of one corridor divided by a dining room with a kitchenette, living areas, "corner bar" where residents can gather for beverages, and a nurse's office that contains a medication room.

The northern corridor is called Silver Lake and is comprised of four studio deluxe resident rooms, two one bedroom rooms, two one bedroom deluxe rooms, and two two bedroom rooms.

The southern corridor is called Myers Lake and is comprised of seven studio deluxe resident rooms and three one bedroom rooms.

Each resident room has a sink and refrigerator in the common area, a full bathroom with a walk in shower, and a pull cord in the bathroom that residents can use to summon staff for assistance. The two bedroom resident rooms have two full bathrooms. Each resident in the newly constructed corridor will be given pendants to wear so they can summon staff for assistance when needed. The pendants will alert staff on their assigned ipods. Each room has a thermostat so residents can control the temperature in their room.

There are keypads located at the outdoor exits in the new corridor. A code is required to exit outside. The five resident rooms on the east side of the Silver Lake area have slider doors that give access to a secure courtyard. The remaining resident rooms have large bay windows.

#### V. Recommendation

I recommend the facility's capacity be increased to 108.
