**II. Purpose of Addendum**

Effective 1/1/19, licensee Beacon Square Orion LLC has changed the name of their facility from Beacon Square Orion to Belmar Pomeroy Living Orion Assisted & Memory Care.

On 1/14/18, I received an email notifying the department that as of 1/1/19, the facility has changed their “doing business as” to Pomeroy Living Orion. On 1/22/19, the facility submitted a formal written request to change their name to Pomeroy Living Orion Assisted & Memory Care. The department approves of the facility name change. The status of the license will remain unchanged.


