II. Purpose of Addendum

To allow the licensee to arrange/designate resident bedrooms throughout the facility as desired as long as the licensed capacity of 20 is not exceeded at any given time. This addendum is a revision to the original licensing study report which limits the licensee to admitting only one resident per bedroom although 6 bedrooms will be designated for multiple occupancy.

III. Methodology

On 12/19/2018, I completed an inspection and the licensee expressed a desire to arrange/designate 5 resident bedrooms as needed according to the resident population as opposed to being restricted to one resident per bedroom as documented in the original licensing report.

On 1/23/2019, I reviewed the original licensing report and it currently documents:

This facility contains 20 Resident Bedrooms and one extra bedroom for utilization if resident family members may be visiting. Every bedroom has an independent full bathroom. Each bedroom will be a single Resident occupancy.

Mr. Ghraib has designated four bedroom types with the following square footage.

Bedroom # 1, 2, 3, 4, 5, 6, 7, 8, 10, 12 and 14 are designated as "efficiency rooms" have a total of 282 sq. ft. each.

Bedrooms # 9, 11, 13 and 15 are designated as "barrier free efficiency rooms" and have a total of 321 sq. ft. each.

Bedrooms # 15 and 16 are designated as "one bedroom deluxe" and have a total of 600 sq. ft. each.

Bedrooms #18, 19 and 20 are designated as "one bedroom" and have a total of 566 sq. ft. each. Bedroom #21 is the designated guest bedroom.

On 12/19/2018, I completed an onsite inspection to inspect all resident bedrooms to determine which bedrooms are in compliance with the required square footage for multiple occupancy. However, room number 17 was not indicated on the original license report and will now be represented on the chart in section IV of this addendum.

On 12/19/2018, I contacted the licensee to provide technical assistance regarding rule R 400.15409 (7) to ensure that each time they arrange a multiple occupancy bedroom, they arrange the beds to provide 3 feet of clearance between beds in the designated multi-occupancy bedrooms.

IV. Description of Findings and Conclusions

The facility bedroom measurements and licensed capacity per bedroom are as follows:

The licensee understands that it is his/her responsibility not to exceed the licensed capacity at any one time according to R. 400.15105

The licensee understands that the total amount of beds in the home is not to exceed the license capacity at any one time according to R. 400.15105.

V. Recommendation

The licensee has been informed that six total rooms in the facility are designated as multi-occupancy rooms. The licensee understands that the total capacity of the home is not to exceed 20 residents and the total number of beds in the entire home is not to exceed 20. This means no extra beds over total capacity of 20 are to be set up in any vacant or occupied rooms.

VI. Recommendation

To revise the room capacity for the rooms numbered 16, 17,18, 19, 20, and 21 to accommodate up to two residents.
