II. Purpose of Addendum

Addition of three bedrooms to the facility.

III. Methodology

On July 8, 2019 the licensee requested a modification of the original license for the addition of three bedrooms to the facility. The facility received an approved fire safety inspection from the Bureau of Fire Services on July 8, 2019. An onsite inspection of the facility was completed on July 30, 2019.

IV. Description of Findings and Conclusions

The facility was originally licensed for 12 residents. The addition is located on the west side of the facility. The addition consists of three resident bedrooms, a storage room and a mechanical room. Each resident bedroom has at least one window, a closet, and a bathroom. The bathrooms have a sink and a toilet. The Northwest Bedroom in the addition has the dimensions 12'2" x 12'1" and 148 square feet. The Southwest Bedroom in the addition has the dimensions 12'2" x 12'1" and 148 square feet. The Southeast Bedroom in the addition has the dimensions 18'7" x 8' and 150 square feet. Each room has an exit door and window. The addition is in close proximity to an emergency exit that is equipped with a wheelchair accessible ramp.

V. Recommendation

I recommend the original license be amended and the facility capacity will continue to be 12 residents.
