## II. Purpose of Addendum

This facility was originally licensed on 05/01/2012 with a capacity of four (4) residents. Brenda McKee, licensee, submitted a request to increase the capacity of this facility to five (5) residents on 08/08/19. Ms. McKee stated that previously, this room was not being utilized. It will now be utilized for one (1) occupant.

## III. Methodology

08/08/2019- Comment.

A request was received from the licensee to increase her capacity from 4 to 5 residents.

An email was received from the assigned consultant requesting an onsite be done in her absence.

08/13/2019- Inspection completed on-site.

## IV. Description of Findings and Conclusions

An on-site inspection of this facility was conducted on 08/13/19. The bedroom that Ms. KcKee requested be licensed for one (1) resident is located on the main level of the home along with the other rooms. This bedroom measures 14 X 8'7" for a total of 120 sq. ft. This is enough floor space for one (1) resident. The bedroom also contained the furniture required for one (1) additional resident.

## V. Recommendation

I recommend that the capacity of this facility be increased to five (5) residents.
