II. Purpose of Addendum

The purpose of this addendum is to modify the language regarding the facility's address in the Original Licensing Study Report dated for December 15, 2016. The address listed for the facility in the report is "1805 Raymond St. Bay City, MI 48706."

According to Public Act 218 rule 400.713(7):

A license shall be issued to a specific person for a facility at a specific location, is nontransferable, and remains the property of the department. The prohibition against transfer of a license to another location does not apply if a licensee's adult foster care facility or home is closed as a result of eminent domain proceedings, if the facility or home, as relocated, otherwise meets the requirements of this act and the rules promulgated under this act.

The proposed change is to change the address to "406 W. Ivy St. Bay City, MI 48706."
