### IV. Description of Findings and Conclusions

Suji Home was originally licensed on 01/27/2017. The facility is a ranch style home with a full walkout on the lower level. The lower level of the facility is split into two sections. The South side of the lower level has one bedroom, a full bath, and a sitting area, which will be used for a resident. The North side of the lower level contains a bedroom for potential live-in staff and a large room for resident activities/meetings. The facility has two exits on the ground level of the lower level, which needed to be modified in order to make the exits and the lower level wheelchair accessible.

On 08/19/2019, I completed an onsite inspection of the lower level of the facility after the licensee made the necessary modifications to make the lower level wheelchair accessible. I reviewed the minor modifications she completed, which included putting small ramps on the inside of the exit doors and concrete ramps on the outside of the exit doors. I measured the ramps and they did not meet the height requirement for handrails. It should be noted there were no physical changes made to the interior of the facility.

#### V. Recommendation

The facility has made the appropriate changes to its lower level and is now wheelchair accessible effective 08/19/2019.
