IV. Description of Findings and Conclusions

On September 11, 2019 licensee, Eric Jefferies contacted the department requesting change in capacity from two residents to three residents. Mr. Jefferies reported that currently there are two residents, the co-applicants Eric and Karen Jefferies and six children residing in the home. The main floor of the home has three bedrooms specified for residents which measured as follows:

Bedroom #1	16' x 21'	336 square feet	2 Resident
Bedroom #2	12' x 11'	132 square feet	1 Resident
Bedroom #1	8'8" X 9'5"	83.6 square feet	1 Resident

On November 09, 2017 and October 05, 2018 there were onsite inspections completed due to addendum requests for change in space. The November 09, 2017 request was to convert the laundry room into a resident bedroom with a private bathroom, which was approved. Then on October 05, 2018 the request was to convert part of living room space into a bedroom with a private bathroom, which also was approved. During the onsite inspection on October 05, 2018 after part of the living room space had been converted into a bedroom and private bath this left 704 sq. ft. of living space. This meets/exceeds the 35 sq. ft per occupant, even after increasing the capacity to three residents.
