2/8/05: Letter to Mr. Andriotti confirming documents received on 2/4/05 and recognition of documents yet to be received.

2/18/05: Grand Rapids OCAL / Meeting with Mark H. Soth to receive final documents.

3/1/05: Compliance met / Update of Computer Licensing System / Duplicate licenses sent to reflect name .

IV. Description of Findings and Conclusions

On 1/26/05, Leisure Living Holdings, Inc. filed a document with the Department of Labor & Economic Growth / Bureau of Commercial Services, requesting a change of registered office and change of resident agent. A Certificate of Correction was issued 1/26/05 reflecting a name change to LifeHouse Retirement Properties, Inc. , 3930 N. Rosebud Court SE, Kentwood, Michigan, 49512. The resident agent was changed from Tom Nobel to Lou J. Andriotti.

On the dates described above, LifeHouse Retirement Properties, Inc. submitted the documents required for the completion of the change in the controlling ownership interest of the original corporation or Limited Liability Company involving twenty facilities. Crystal Manor #3 was one of those twenty facilities.

In accordance with requirements, LifeHouse Retirement Properties, Inc. submitted the following documentation: Adult Foster Care Corporate Application (without fee), copies of pertinent company documents, a current listing of corporate directors, current organizational charts, written designation by the board of directors of the individual authorized to act on behalf of the corporation on licensing matters, designation of the person who will be immediately available and have the authority to carry out the licensee's or administrators responsibilities in their absence, current financial statement for the corporation, Licensing Record Clearance Requests, Licensing Medical Clearance Requests and documentation of required competencies for the new administrators and licensee designee.

On 3/1/05, compliance to the above requirements was achieved.
