**II. Purpose of Addendum**

The licensee requested that the capacity of her facility be increased from three to four AFC residents.

**III. Methodology**

10/20/2003: I met with the licensee at her facility and measured rooms.

**IV. Description of Findings and Conclusions**

Ms. Wynsma and her three children are the only non-AFC residents residing at the facility. In order to accommodate a fourth AFC resident Ms Wynsma would have her daughter move from the main floor bedroom to an upstairs bedroom.

The bedroom in question has 170.26 square feet. After deducting the space under the portable wardrobe that leaves 144.26 square feet. That exceeds the minimum 65 square feet standard set by Rule 400.1432(1).

The living room and dining room area total 403.32 square feet. When divided by the number of household occupants (eight) that comes to 50.41 square feet. That exceeds the minimum 35 square feet per occupant standard set by rule 400.1427(1).

**V. Recommendation**

It is recommended that the capacity of the facility be increased from three to four AFC residents.
