III. **DESCRIPTION OF FINDINGS & CONCLUSIONS**

This evaluation is based upon the requirements of P.A. 218 of the Michigan Public Acts of 1979, as amended, and the Administrative Rules and Regulations applicable to the licensure of small group facilities (1-6), licensed or proposed to be licensed after 05/24/1994.

A. Physical Description of Facility

Scotland Manor is a small adult foster home located in St. Clair, MI. The home is located on the St. Clair river. Scotland Manor has a capacity of six residents. The home has city water and sewer. Parking is available in the circle drive in the front of the home. The home is the personal residence of licensee Mary Black who occupies the main floors of the home. The adult foster home is located in the walkout basement portion of the home and is considered Unit B. A property record was received that stated the home is owned by David and Mary Black. Ms. Black provided a signed letter dated 08/20/2018 giving permission to inspect for licensing.

Scotland Manor has previously operated as an unlicensed adult foster care home. I completed an onsite inspection for initial licensing on 08/20/2018. Ms. Black stated that there were no residents residing in the home and indicated that renovations were being made to the basement for the purposes of licensing. During the onsite inspection, a relative arrived to visit a resident and a staff member appeared for their shift. A meeting was held on 09/07/2018 with Adult Foster Care Area Manager Denise Nunn, Mary Black and Attorney Greg Bator. Mary Black stated that at the time of inspection there were three residents residing in the home.

Scotland Manor has a capacity of six residents. The home has three bedrooms, two and a half bathrooms, kitchen, dining area, living area, laundry closet, spare room and storage room. The home has two furnaces in basement with self-closing fire door. The bedroom and bathroom doors are equipped with positive latching, non-locking against egress hardware. The living and dining area offer a total of 659 square feet of living space which meets the required 35 square feet of living space for six residents.

The three bedrooms in the home measure as follows:

Total Capacity: 6

The bedrooms have adequate space, bedding, storage and a window/door that opens in case of emergency. All of the bedrooms have a chair and a mirror. The refrigerator and

freezer are equipped with thermometers. Medications are kept in a locked cabinet in the kitchen. During the onsite inspection through my observation, the home was found to be in substantial compliance with rules pertaining to maintenance and sanitation. Emergency procedures were posted in the home and fire alarms were in working order at the time of inspection. A fire extinguisher was located in the basement. I measured the water temperature with a digital thermometer and found the water to be 108.5 degrees Fahrenheit. The home has alarms on basement doors that lead to river. Inspections for the furnaces and water heaters were completed on 08/16/2018 by Robins Aire Temp Commercial and were given "fair" ratings.

B. Program Description

A copy of the program statement was provided for Scotland Manor. The statement indicates that the home will serve the elderly, generally those over the age of 65 and residents with Alzheimer's disease and dementia. They are also equipped to serve physically handicapped residents as the AFC home is located on one level. The home will provide personal care for residents including assistance with food preparation, eating and toileting, bathing, grooming, dressing, transferring and ambulation assistance. The home will also provide recreational activities that include board games, group discussions, card playing, horseshoes and picnic activities in yard.

A copy of Scotland Manor's staffing schedule was provided. The home will have one staff per shift.

Mary Black is the licensee for Scotland Manor. Ms. Black has been previously qualified and is the licensee designee/administrator for River's Edge Assisted Living (AS740282833). River's Edge Assisted Living has been licensed since 10/26/2006. Ms. Black has been fingerprinted. She provided a medical statement which indicates she has no physical/mental or health problems that would limit her ability to work with or around dependent adults and TB test dated 09/04/2018.

Ms. Black's husband, David Black, has also resided at Scotland Manor. Ms. Black stated that her husband is currently residing at 322 Riviera St. Clair Shores, MI 48080 and provided a copy of his driver's license with address change. A clearance was completed for Mr. Black on 08/13/2019. A medical statement was provided for Mr. Black dated 08/15/2019 which indicates she has no physical/mental or health problems that would limit her ability to work with or around dependent adults. Mr. Black had a negative TB test on 08/17/2019.

Ms. Black has provided a signed letter designating, Amelia Black, as designated person in her absence.

C. Rule/Statutory Violations

The applicant was in compliance with the licensing act and applicable administrative rules at the time of licensure.

IV. RECOMMENDATION

I recommend issuance of a temporary license to the small adult foster care group home, Scotland Manor, with a capacity of six (6) residents.

The temporary license will be in effect for a six-month period. Another licensing renewal will be conducted after six months.
