II. Purpose of Addendum

The purpose of this addendum is to determine if the Northwest bedroom of this facility is suitable to accommodate two residents. It is currently licensed for one resident but the licensee wants the flexibility to allow two residents of the same gender or a married couple to reside in this room. The licensee understands that if this request is approved, she is not to exceed her licensed capacity of six residents at any time.

IV. Description of Findings and Conclusions

On 9/28/17, I conducted an onsite inspection of this facility. I measured the Northwest bedroom and found it to have 168 sq. feet of usable floor space. In addition, the bedroom meets all of the requirements to accommodate two residents.

V. Recommendation

I recommend that the Northwest bedroom of this facility be licensed to accommodate two residents. The licensee understands that at no time is she to go over her licensed capacity of six residents.
