requested in the Change in Controlling interest letter including information regarding the designated person, current financial statement(s), copies of Ms. Allen's trainings, copies of any paperwork that has been update (i.e. policies), copies of any company documents that have been filed or revised.

On 12/04/2019, I received information via email regarding the corporation's financials, designated person, and a Beneficial Owner Certification with Ms. Allen listed as president of the Deer Run Rehabilitation, Inc with 100% ownership.


On 12/06/2019, I received two emails from Ms. Allen with the remainder of the requested documentation (i.e. copies of trainings, etc.).

I recommend that the licensee designee is changed from Colleen Bachman to Janet Allen.


