II. Purpose of Addendum

The purpose of this addendum is to add Special Certification to the home’s program for residents with Mental Illness.

III. Methodology

On 1/24/20, I received an *Application for Certification – Modification* from the licensee, requesting to add MI (Mental Illness) to the facility’s Special Certification.

I reviewed the licensing file and determined that the facility is licensed to serve persons with mental illness.

IV. Description of Findings and Conclusions

Licensee Designee and Administrator Kent VanderLoon is a college graduate with over 15 years’ experience working with persons with both mental illness and developmental disability. Mr. VanderLoon has demonstrated his ability to provide care to both populations in numerous AFC facilities licensed to McBride Quality Care, Inc.

The facility is currently licensed to serve persons with mental illness or developmental disability. The facility’s Program Statement includes both DD and MI programs.

According to training records maintained by the licensee, all staff in the facility have completed CenTrain Group Home Curriculum from CMH for Central Michigan, which includes training for both MI and DD populations.

V. Recommendation

I recommend that the Special Certification issued to McBride Sherman Street Home be modified to include both MI and DD programs.
