II. Purpose of Addendum

The purpose of this addendum is to document an increase in licensed bed capacity. The facility requested to make their single occupancy resident rooms double occupancy rooms.

III. Methodology

On 5/5/20, I received notification from Health Facilities Engineering Section (HFES) engineer Pier-George Zanoni that there is adequate dining, activity, and window space to make all resident rooms double occupancy.

On 5/11/20, I received an updated application to increase the facility's licensed bed capacity from 37 to 56.

IV. Description of Findings and Conclusions

Vista Springs Center for Memory Care and Rediscovery is a one-story building. The campus the facility is located on includes three adult foster care facilities and this freestanding home for the aged (HFA).

The HFA facility is a secured memory care unit and requires a code to be entered for admittance. There are 28 resident rooms in the facility. Each resident room has its own barrier-free bathroom containing a toilet and sink. Additionally, each one bedroom living unit bathroom is outfitted with its own shower. Single units are outfitted with a large screen television, sink and cabinet in the living area and approximately 135 square feet of open floor space. Suite units have two separate sleeping areas that are approximately 90 and 130 square feet in size with approximately a 90 square feet common living area. Directly outside the large day dining area space is a landscaped outdoor area secured by a fence that allows residents to enjoy the outside safely and participate in facility guided outside activities.

V. Recommendation

I recommend the facility's capacity be increased to 56.
