II. Purpose of Addendum

The purpose of this addendum is to document the increase in licensed resident capacity from four residents to six residents.

III. Methodology

October 15, 2020 – An on-site inspection was conducted to measure a spare bedroom to now be used as a resident bedroom.

IV. Description of Findings and Conclusions

The resident bedroom measures 14'10"X 9'10" or 146 Sq. ft. less space beneath two portable "closets" of 2'X3' each. Total usable floor space is 132 Sq. ft.

This bedroom can accommodate a maximum of two residents

The facility is now authorized to provide care for a maximum of six residents.

V. Recommendation

I recommend the license be modified to authorize care of a maximum of six residents effective October 15, 2020.
